

The swap was deducted from the position, but the profit was cancelled due to unreasonable addit Additionally, support confirmed that the correct swap short for USDJPY is -3.9. Only if the trade was initiated overnight would

Again, there is a discrepancy here. Note that after the improper collection, the swap point was changed to -35.19. This is odd b ecause -3.9 should be correct.

When I contact the support that they explain they will respond within 12-24 hours.

However, no response by the deadline and if you contact them again, the response is just being processed. I assume they are b usy processing fraud.

The answer that finally comes is "trading activity is verified by LPs because there appears to be abuse of the trading platform. Of course, this is a transaction i do not recall.

As you know, LPs are price and liquidity providers and there is no way for an LP to individually scrutinize trading records. This i

s a malicious lie and an unfair description that confuses users with jargon

[Problem solved]
On January 4, Gauray J, Coinexx's Executive Director and Head of Customer Relations, apologized for the disturbance and retur ned the unjustified adjustment, and the withdrawal was completed in full.

There was no response to this inquiry until the end of the day.

The content of the last e-mail was also questionable,

Since our goal is to complete the withdrawal, we will refrain from pursuing the matter as long as we have done so.

Although the matter was finally resolved, the response leading up to the resolution was not of the highest quality, and without my pressuring approach, the funds would have been taken away.

I am not sure what was the deciding factor in posting on various review sites, reporting to MetaQuotes, X, spreading the word o n FB, etc., but it seems to work.

The many screenshots left in this thread may also help you.

We have evidence of many other discrepancies that we have not posted in this thread, so please contact us if you have been si

milarly victimized by COINEXX.



By the way, we will make up the \$760 in the name of shortfalls reversed in the past due to the same irregularities. After the last sterile exchange, the issue was resolved in the form of compensation to MT4.

In other words, they have a criminal record and are trying to commit fraud again using the same tactics.

Some of you may have suffered the same losses.

There is no sign of remorse and they are very malicion.

A withdrawal of 102.374USD was requested on December 8.

It was supposed to be processed within 48 hours, but was not.

Subsequently, due to falsified transaction records and improper swap recovery, the benefit was cancel.

The remaining amount (USD 69,011) was explained to have been paid on 12/22, but only USD 66,942 was received.

You are missing the point. We are not currently seeking a genuine statement of a trading strategy.

Nor have we pointed out any details regarding the improper use of the trading platform.

What is improper use of the platform in the first place? Of course we do not know, nor do we know what kind of behavior it is.

We have received testimony from chat agents that there are no restrictions on their use of COINEXX and that they do not interf ere with their clients' transaction records.

We use COINEXX with the assurance that there are no restrictions. If there were certain restrictions we would naturally avoid th

Rather, is it unfair to bring up fraud and prohibitions after the fact?

If you have read this thread.

Do you understand how mallicious that is?

All we want is proper profit extraction. If you have users around you, let them know so there are no new victims.

I suggest you check the money received at wallet address 0x1d71aab877925e8cfe19f67e5a6d324ed6a32c3d.

The only transfer that can be verified from Etherscan is 66,942 USDT.
The total for the three cases (\$28450, \$23924.72, \$16637.28) is \$69,012.
Where did the difference disappear?
It colars stated that they correctly transferred the money, they should be able to show proof with a transaction like Etherscan.
However, at this time no neutral evidence is presented, only a one-sided completion statement.

While no evidence can be presented, this is akin to an admission of fraud.

If the money is correctly transferred, there should be no problem. We too instructed them to show neutral evidence, not MT or website withdrawal request records that could be falsified. We are waiting for your nepty.
